A Fair Shake for Youth worked with 125 youth in 10-week programs in 10 middle schools before COVID-19 shuttered schools. A Fair Shake pivoted to offer remote SEL programming that reached 125 middle school students and created a new and innovative "Zoom Reading Aloud to Dogs" program that helped 75 elementary school children reading below grade and attending underperforming public schools build critical literacy skills. In-person reading to dogs programs have proven to increase a child's reading confidence because dogs don't judge, interrupt or correct. Through a new collaboration with the Marlene Meyerson JCC Manhattan's remote tutoring program, participants read to our dogs on zoom.
